## 2013 NEVADA PROSECUTORS CONFERENCE

### HARRAH'S LAUGHLIN – LAUGHLIN, NV

### SEPTEMBER 25-27, 2013

The Nevada Advisory Council for Prosecuting Attorneys, in conjunction with the Nevada District Attorneys Association, will host the 2013 Nevada Prosecutors Conference in Laughlin from September 25-27. The Conference will include continuing legal education presentations, meetings of the Advisory Council and the Association, the Prosecutors Banquet and 2013 Raggio Award presentation on Wednesday night, and a Prosecutors Golf Outing at Cerbat Cliffs Golf Course on Thursday afternoon.

This Conference is designed for prosecuting attorneys who represent the state or local jurisdictions, features speakers that have been selected for their expertise in legal issues relevant to Nevada's prosecutors, and provides a great opportunity to network with prosecutors from throughout Nevada.

The Conference will be held at Harrah's Laughlin; take US-95 S toward Searchlight and turn left on NV-163 E to Laughlin. Contact Harrah's Laughlin at 1-877-881-5955 and reference the Nevada Advisory Council for Prosecuting Attorneys Group Code **S09NAC3** for the conference room rate of \$22.99/night plus tax.

There is a \$150.00 registration fee for this 10.0 hour CLE credit (1.0 substance abuse/1.0 ethics) conference. The fee includes all conference materials, continental breakfast on Thursday and Friday, lunch on Thursday, and the Wednesday night Prosecutors Banquet. Checks should be made payable to the Advisory Council for Prosecuting Attorneys; please include payment for additional guests for the Prosecutors Banquet at time of registration. **REGISTRATION DEADLINE IS SEPTEMBER 13, 2013.**

A limited number of prosecutor scholarships (funded through Justice Assistance Grant Project No. 10-JAG-32 and Nevada Office of Traffic Safety Project No. LFD-2013-Ad Council-PA-00045) are available to reimburse lodging for up to two nights at the state per diem rate and the \$150 registration fee, for a total reimbursement not to exceed \$304 per prosecutor. No other expenses are eligible for reimbursement and prosecutors must attend the entire conference for any scholarship reimbursement.
