**2014 NEVADA PROSECUTORS CONFERENCE**  
**Harveys Resort – South Lake Tahoe, NV**  
**September 10-12, 2014**

The Nevada Advisory Council for Prosecuting Attorneys, in conjunction with the Nevada District Attorneys Association, will host the 2014 Nevada Prosecutors Conference at incomparable Lake Tahoe from September 10-12. The Conference will include continuing legal education presentations, the Prosecutors Banquet and 2014 Raggio Award presentation Wednesday night, meetings of the Advisory Council and the Association, and a Prosecutors Golf Outing at Lake Tahoe Golf Course on Thursday afternoon.

This Conference is designed for prosecuting attorneys who represent the state or local jurisdictions, features speakers that have been selected for their expertise in legal issues relevant to Nevada's prosecutors, and provides a great opportunity to network with prosecutors from throughout Nevada.

The Conference will be held at Harveys Resort in South Lake Tahoe. Contact Harveys Resort at 1-800-455-4770 prior to August 11<sup>th</sup> and **reference the Nevada Prosecutors Conference** for the conference room rate of \$69/night (plus tax) for a Mountain Tower standard room or \$89/night (plus tax) for a Lake Tower standard room. South Lake Tahoe is located on US 50 connecting with US 395.

There is a \$150.00 registration fee for this 10.0 hour CLE credit (2.0 ethics) conference. The fee includes all conference materials, continental breakfast on Thursday and Friday, lunch on Thursday, and the Wednesday night Prosecutors Banquet. Checks should be made payable to the Advisory Council for Prosecuting Attorneys; please include payment for additional guests for the Prosecutors Banquet or for the Prosecutors Golf Outing at time of registration.

A limited number of prosecutor scholarships (funded through Nevada Office of Traffic Safety Project No. 2014 Ad Council-PA 00029 and Violence Against Women Act STOP Subgrant No. 2013-STOP-47) are available to reimburse lodging for up to two nights at the state per diem rate of \$88/night and the \$150 registration fee, for a total reimbursement not to exceed \$326 per prosecutor. No other expenses are eligible for reimbursement and prosecutors must attend the entire conference to be eligible for any scholarship reimbursement.
